These programmes all start in September. They consist of 9 months of courses, a thesis and a 3-6 month internship in France or in the country of your choice.

The requirements to apply to our MSc programmes are to:

- 1 Hold a Bachelor degree,
- 2 Have an acceptable score on the GMAT exam,  
Please refer to the EDHEC website for individual programme requirements.
- 3 Speak fluent English, proven by an English Test as a Foreign Language (TOEFL > 100, TOEIC > 900, IELTS > 6,5 or Cambridge Test of English: "pass"). You can apply for an English Proficiency Test Waiver if you are a native-English speaker or if you can prove that you have previously studied or worked in the English language.

The MSc tuition fees for the academic year 2009/2010 are 13 900 euros.

A limited number of merit-based scholarships are available. Full information on financial assistance is listed on the admissions page of the MSc websites. Please note that all financial aid from EDHEC Business School is reserved for applicants with excellent profiles.

The deadline to apply is the 30th June 2009.
